## **SPECIAL GENERAL BODY MEETING HELD ON 07<sup>TH</sup> APRIL 2019 AT THE CLUB PREMISES, FOLLOWING IMPORTANT AMENDMENTS TO THE RULES OF THE KORAMANGALA CLUB WERE APPROVED BY THE AUGUST BODY**

Rule- 3.3.1 Resident Members: The members who are permanent residents of the Koramangala layout by virtue of their owning an immovable property or a site in their own name or in the name of the spouse or parents shall be called the "Resident Members". Koramangala layout means & includes the area comprising Koramangala block Nos. 1 to 8, ST Bed, villages of Koramangala, Maistrypalya, Kathalipalya, Koramangala industrial layout, NGV complex & Venkatapura and all areas under pin codes of Koramangala that is 560095 & 560034 including Ashwini layout, Chandrareddy layout & Venktareddy Layout as declared from time to time by the Bangalore Development Authority and / the Bangalore Bruhat Mahanagara Palike as the case may be.-Approved

Rule-3.6.1 Enrolment of Temporary Membership of 300 Members for 1 year at Rs.1 lakh Non-refundable. Subject to screening of the Members by TKC Managing Committee.-Approved

Rule- 3.6.2 Long Term Temporary Membership for 3 years at a fee of Rs.2,50,000/- plus GST of 18% on Rs.50,000/- Rs.2,00,000/- shall be Refunded after 3 years of locking period without interest - This intake of Membership is restricted to 100 candidates only.-Approved

Rule- 3.6.3 Platinum Membership for a period of 10 years .Rs.20 lakhs for facilities support and additional Rs.30 lakhs for Branding.-Approved

Rule- 8.1.6A For Bulk membership of 50 Nos & above Rs.1 lakh concession will be given.-Approved (For resident/non-resident candidates)

Rule- 9.1(A) All Permanent Members & NRI Members who opt to pay a onetime payment of Rs.40,000/- Plus GST shall be exempted from paying Monthly subscription to the Club.-Approved

(B) All Permanent & NRI Members who opt to pay a onetime payment of Rs.40,000/- plus GST shall be exempted from cover charges for non-usage of the Club facilities.-Approved

Rule- 10.1 All Members excluding Honorary Members shall be eligible for a credit facility not exceeding Rs.10, 000/- in any calendar month. The amount utilised by the member under this credit facility will be billed by the Club for that particular calendar month which needs to be cleared by the member as stipulated.-Approved

Rule- 10.8 The monthly bills of the Club will be sent to the Members by Email /SMS only. No hard copy will be printed and sent. All bills shall be emailed to the members on or before 10th day of every calendar month, notifying "pay by date", which shall be the last day of the month. However a statement can be requested in the Club Office if required.-Approved

Rs. 1,000/- shall be debited to all members account towards building development fund for 10 months starting from August 2019 as per SGM approval.

**The Special General Body Meeting held on Sunday 7th April 2019 has unanimously resolved to collect Rs.10,000/- per Member from all Members towards Building Development fund. All Members are requested to pay the Building development Fund at the earliest.-Approved**
